MEMORANDUM OF UNDERSTANDING

between

the Chamber of Commerce and Industry of Serbia

and

the Kosovo Chamber of Commerce

The Chamber of Commerce and Industry of Serbia (CCIS) represented by President Željko Sertić and Kosovo Chamber of Commerce (KCC) represented by President Safet Gërxhaliu , here in after referred to as "CCIS" and "KCC"

- driven by the mutual desire to contribute to the development, promotion and diversification of the trade exchange, economic cooperation, commercial and cultural relations between their business communities on behalf of the mutual interests and in accordance with the laws and regulations of the two parties,
- bearing in mind that this MoU does not cover any other issues which are not mentioned in this document (i.e. political, property or other topics)

have concluded the following:

Article 1

The CCIS and KCC shall support their membership enterprises in various trade and economic cooperation, including investment in exploitation, joint venture, cooperative production and similar as well as to provide them with facilitation services.

Article 2

The CCIS and KCC shall take initiatives to exchange on a regular basis trade and economic information, help each other to understand the market and the policy in terms of trade and investment for the necessity of cooperative projects.

Article 3

The CCIS and KCC shall regularly exchange statistics, economic data, magazines and periodicals directories and other information and publications that might be needed by their respective business communities.

Article 4

The CCIS and KCC shall disseminate to the circles on either side information on purchase, sales and cooperation from respective members, help each other and assist the members to promote partnership opportunities.

Article 5

Each party shall exchange trade delegations and missions, assist each other to arrange visits and organize business and trade seminars, business meetings and other business activities needed.

Article 6

Both CCIS and KCC shall provide each other with the information on the main exhibitions and trade fairs, promote the trade and services and help each other to arrange participation, visits and other related activities.

Article 7

Both CCIS and KCC shall encourage the institutional partnership in research and development, training facilities and implementation of different EU projects. Concerning the aforesaid issues, both parties should consider the exchange of the staff for a certain period of time.

Article 8


The present Memorandum enters into force on the day of its signature and remains valid unless one of the Parties requests its termination. The Memorandum will be elaborated in the English language.
